Call to Order, Introductions, Welcome	
The meeting was called to order by President Wendy Loly at 0933 PST;	
members in attendance was 52 so quorum was achieved and the meeting	
could proceed. Total attendance including guests was approximately 100	
people.

attendance but Grace was listening in via telephone from PEI; Wendy thanked	
the volunteers (those wearing nametags) and noted that all the documents	
under discussion today were available on line prior to the meeting and hoped	
that all had perused them.

President's Report (Refer to PPT Presentation)	
Wendy noted that when she I took on the presidency of CCoP in January of	
2016, she had goals regarding memberships, communications, finances,	
databases and governance.	
One of the roles of the national organization is to build community through	
communication accomplished by the website which was set up by Julie	
Rosenthal, the 'Virtual Administrator". Neville has been instrumental in	
handling the website notices of events and the Member Area resources. He	

has also been diligent in posting on Facebook and so increasing the interaction with the Camino community. Newletter editor is Cecelia Pineda of Powell River, BC. As you can see much of this work is done electronically.	
Chapters are the heart of CCoP, where the 'work' of nurturing our members gets done, so one goal was to strengthen the communications between chapters; CCoP has grown from the bottom up while other Camino organizations started at the national level and then added local or regional chapters after that; since we have done it in reverse, we are presented with unique challenges.	
Better communications between the Chapters would help the chapter leaders to share their innovative ideas and strengthen our organization. This year we have set up a Dropbox where Chapter leaders can share resources. The goal since the beginning has been to bring them all together for face-to-face meeting now scheduled to take place in Victoria in March, in conjunction with the Victoria Spring Pilgrim Gathering; all 15 chapter coordinators from across Canada will meet and this is also a part of the succession plan.	
Action: to keep costs down, billets are needed for all guests rather than pay for hotels; still require couple of beds and/or drivers. Anyone who can assist, it would be appreciated.	Email or see Terry Costain or Wendy.
Hospitalero Training: CCoP has a training team, headed by Mary Virtue (Victoria) and Tom Friesen (London ON); they have produced materials being used or adapted by other international Camino associations and have worked with Judy Gayford (Calgary) and Daphne Hnatiuk (Vancouver) for the 2017 trainings. This is an important part of our service to the international Camino community.	
Memberships: Historically, folks join when they need a credential but only a few support CCoP otherwise; this somewhat addressed with online renewals. As the Chapters grow, they need support to do their jobs of nurturing pilgrim gatherings in their communities; they are providing support to both new and returning pilgrims, and the national level supports the Chapters. This year CCoP has paid for insurance and helped some new chapters with their costs.	
Each Chapter keeps its own email lists; one may be on a Chapter email list but not actually be a member of CCoP; there is no fee to be associated with one of the local chapters. The membership fee of \$10/year is paid to the national level. One of our goals for 2018 is to move toward bringing these email lists together and making them accessible to both chapters and the national organization.	
Those in attendance who were not members were encouraged to join up after the meeting, mail in a paper membership form with a cheque, or order and pay online.	

In 2016, the CCoP membership list was in a Yahoo address book; in setting up	
the website that data was moved to a basic database which has served well for two years but now time to upgrade to a more robust system, at what will be an increased expense. This must be reflected in our ongoing annual budgets.	
Credencials: Issued 1,448 credentials in 2017, 10 more than previous year; incoming orders dealt with by Secretary Grace in PEI, sent back to Victoria to be filled and mailed each Monday; even before you receive your new credential its information has travelled back and forth across Canada!!	
Peaks and valleys to number of incoming orders, according to the season, with March and Aug-Sept being busiest. However we've seen a 20% increase in orders this January over same month last year! Please allow processing time when ordering – we sort by departure date only when orders are heavy. Finances: Anticipated infrastructure costs for 2017 so cut back on donations	
until costs determined and covered. National level has always supported the chapters financially to help cover the	
costs of their meetings; in past it was possible to get FREE space, but that is becoming more difficult; as Chapters grow, they require larger spaces which are more costly and their revenues don't always cover these costs. Also, as chapters grow, so do their email lists which become more difficult to handle. So some larger chapters have moved to MailChimp for their email maintenance and delivery. This year the National level arranged insurance coverage for Directors and Chapters, and this will now be an ongoing expense.	
Did make some donations in 2017: for operating support at the two albergues run by the Confraternity of St. James (at Rabanal and Miraz); for purchase of two computers for Pilgrim House in Santiago; and also to provide support, badges and credencials to eleven military members who walked the Camino in April 2017 as part of their healing process from Post Traumatic Stress Disorder; some of the larger chapters made substantially larger gifts to support other albergues or purchase needed supplies for them (e.g. mattresses).	
External Roles: in contact with Quebec Camino group and also International roles; Past-President Austin Cooke is our Embassy Liaison, meets several times per year with the Spanish Ambassador and presents books, films about the Camino that are produced by Canadians.	
Sent a rep to American Pilgrims on the Camino (APOC) meeting; CCoP should be present there to ensure good links with that group as interests are often of a similar perspective from this side of the ocean.	
Relationship with European associations has allowed us to have today's guest speaker from Ireland; as well as close connection with Xacabeo group in Galicia.	

Vice-President's Report (Refer to PDT Presentation):	
Vice-President's Report (Refer to PPT Presentation): Neville Tencer introduced the new role of Vice-President where he is involved	
in a great deal of the communications for the CCoP; he updates the events on	
the website and FaceBook; dealt with obtaining insurance to cover both the	
national level and the Chapters; managed the renaming of the newsletter	
naming contest; updated the Members Only section of the website; and	
generally keeping everyone up-to-date on what is happening on the Camino.	
Neville noted that the increases in pilgrim numbers have been consistent over	
the last several years but that more people are now walking routes other than	
the Camino Francés. He also discussed the makeup of FaceBook users	
(mostly women) and we can use that as a proxy for the breakdown of	
members in the CCoP. Indeed, more women place orders and are,	
apparently, making the decisions about going on the Caminos. On FaceBook,	
users like pictures, stories and information on safety issues; items on history or	
Caminos outside of Europe have less uptake; he reiterated that the Chapters	
are crucial to introducing people to the Camino and to CCoP and thus are key	
to the organization. Since membership is a primary sources of our revenues,	
we need to work on the fact that although we have 5000 people on mailing lists	
over fifteen chapters, we only have 1500 members.
