The **Canadian Company of Pilgrims** (CCoP) is a volunteer-run, not-for-profit corporation that includes 18 regional chapters. It is overseen by a Board of 13 volunteer Directors from across the country. Directors are active members of the organization; ours is very much a working board. Some Directors serve as Officers, all are expected to serve on one or more committees, and some are also Chapter coordinators. CCoP Directors serve for a three-year term (renewable once) and manage the operations of the organization, including finances and investments, marketing and communications, information technology, governance, international relationship building, membership, event planning, and more. Along with possible committee and officer meetings, Directors are expected to attend 10 virtual meetings per year (via Zoom) and to be proficient using applications like Word or Pages, Excel or Numbers, and Dropbox. Our mandate is to have a Board of Directors that includes a geographically diverse group of open, generous, and hospitable individuals that share our love of the Camino and want to be part of a vibrant and inclusive community.
